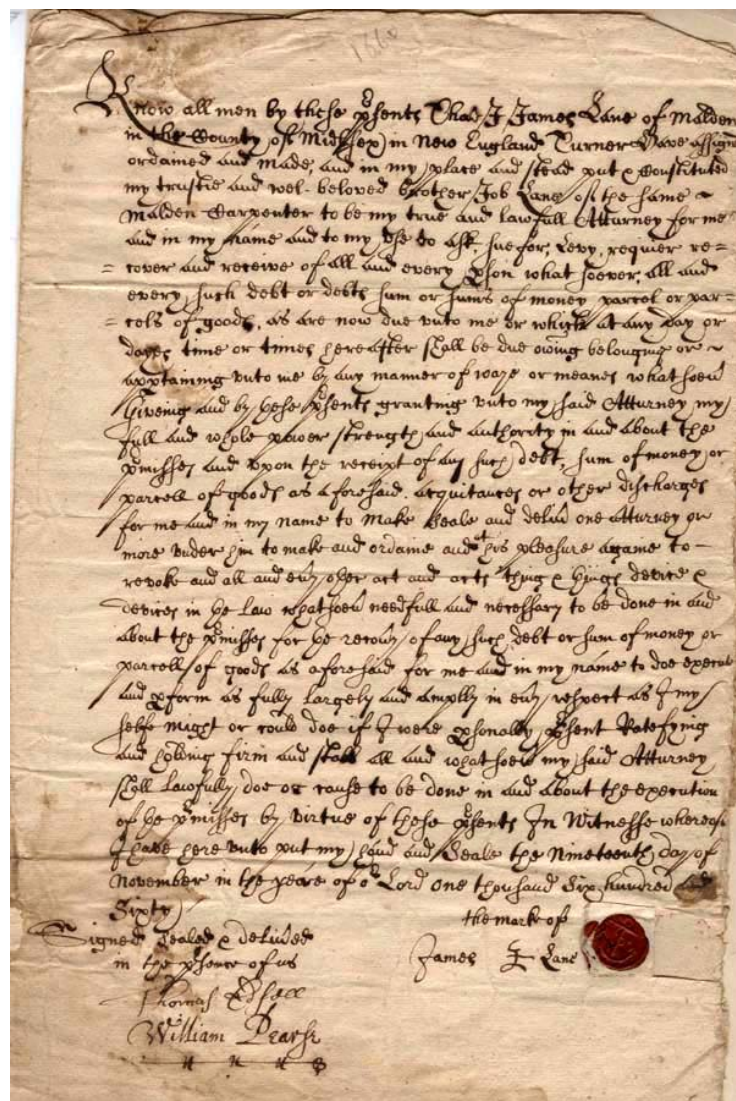


#42A November 19, 1660

Power of Attorney, James Lane to Job Lane



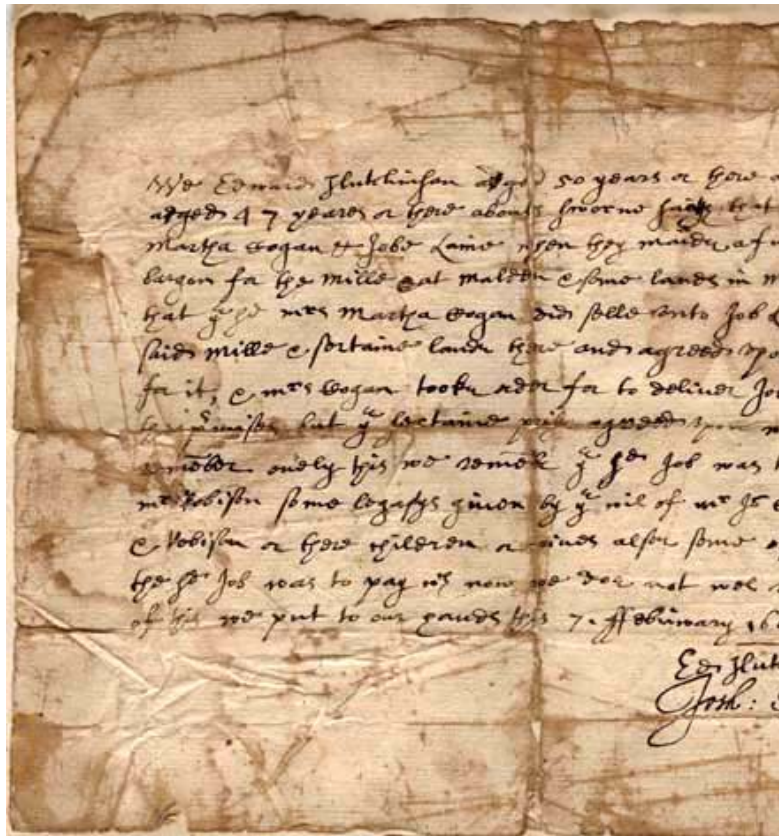
[Note: Words in red are uncertain.]

Know all men by these presents that I James Lane of Malden in the county of Middlesex in New England **Turner** have assigned ordained and made, and in my place and stead put & constituted my truthful and wel beloved brother Job Lane of the same Malden carpenter to be my true and lawfull attorney for me and in my name and to my use to ask, sue for, levy, requier recover and receive of all and every person what so ever, all and every such debt or debts sum or sums of money parcel or parcels of goode, as are now due unto me or which at any day or days time or times hereafter shall be due owing belonging or ~ appertaining unto me by any manner of ways or money what soevr Giving and by these presents granting unto my said Attorney my full and whole power strength and authority in and about the premisses and upon the receipt of any such debt, sum of money or parcell of goods as a foresaid. acquitances or other discharges for me and in my name to make seale and deliv^r one attorney or more **buder** him to make and ordain and at his pleasure againe to revok and all and eny other act and acts thing & **things** device & devices in the law what soev^r needfull and necessary to be done in and about the premisses for the recovery of any such debt or sum of money or parcell of goods as aforesaid for me and in my name to doo execute and perform as fully largely and amply in every respect as if my selfe might or would doo if I were personally present **satefying** and holding firm and shall all and whatsoever my said attorney shall lawfully doo or cause to be done in and about the

execution of the premisses by virtue of these presents In witness

We Edward Hutchinson aged 50 years or thereabouts & Joshua Scottow aged 47 years or thereabouts **?scor** we sayth, that being **?that** with Mrs Martha Cogan & Job Laine when they maide a full and compleate bargon for the mille at Malden & some lands in Malden doth testify that the said Mrs Martha Cogan did selle unto Job Laine of Malden the said mille and certaine lande there and agreed upon a certaine price for it, and Mrs. Cogan took order for to deliver Job Laine posetion of these premises but the sertaine price agreed upon we doe not wel remember only this we remember that sd Job was to pay Mr **?Pockr** and Mr Robinson some **?legastys** given by the mil of Mr J Cogan to the sd **Pock** & Robinson or there children or **?asines** also some other debts or legacy the sd Job was to pay with now and doe not wel remember to the truth of this we put our hands this 7 February 1662

Bee it known to all men by this present that I William **Wilkinze** of the parish of Chesam in the countie of Burks [Berkshire] labourer have and do hereby make and constitute my well beloved friend Job Lane of New England of the parish of Malden carpender my true and lawfull attornie for now and in my name to akte and transakte as occasion shall present for the recovering of the sume of five pounds given to me by Abaraham Willkenze ^{^my son} whom hee my sayd trustid friend here fore named shall fiend if to be due togetherwith the interest as shall appear to bee due for the same and whatsoever this my attorney shall doo for mee or my name other by sute at the law or other wise by composition under his hand of the sayd William Wilkin doo hereby engage and bind myself to mayntaine and to perform **??//ally** as if **??** my selfe **???** been present and don if and in wittnes heirof I the sayd William have hear unto put my hand and seale on the 6 day of Aprill in the yeare of our Lord Christ 1658
